  - a. Employee 457 Plan: We will be bringing a recommendation to the Finance Committee for a change in vendor for our employee 457 plan. The current plan and two alternatives were reviewed and a recommendation to change vendors is being made.

    - i. Inpatient Service Line Senior Executive: Search firm (Barowsky Search Partners) working on sourcing candidates. Hope to have position filled by the end of summer
    - ii. Director Inpatient Behavioral Health and Crisis Services: Filled; candidate to start on 6/4/13
    - iii. Pharmacy Director: Receiving many resumes. Several interviews conducted. No viable candidates yet.
  - c. Facility Updates:
    - i. Main entrance: expected to be completed within two weeks
    - ii. Human Resources: to be completed by early fall
    - iii. Pharmacy: anticipate to be project for 2014
  - d. Psychiatry: continuing to work on development of the "co-branded" solution with Bridge Community Clinic. Working on developing memorandum of understanding. Hoping to bring it to the board in June.
  - e. Multi-County Human Services Model Feasibility Study Committee: sub-committee to select facilitator meeting 5/15/13 and hoping to arrive at a recommendation to be made to committee for its next meeting on 5/29/13.
  - f. Nursing Home Master Facility Plan: Oversight committee hopes to have recommendation completed by June 11 so that NHOC can approve on 6/14/13, NCHC Board and Marathon County HHS Committee on 6/27/13 and Marathon County CIP in July.
  - g. The Human Service Center: The Human Service Center (Vilas, Forest and Oneida Counties) going through a leadership transition with the retirement of the executive director. Gary sent them information about collaborative services with NCHC.
  - h. Brown County: Toni Simonson working with Brown County to assist them in the development of a crisis CBRF similar to ours.
  - i. DHS Integrated Care Pilot: DHS applying to Federal government to participate in the pilot.

- j. In-House Physician Services: Continuing to work with Marathon County and City of Wausau to explore the potential for development of in-house physician services for employees.
