- 5. Psychiatry Recruitment: working on selecting recruitment firm. Need for Psychiatry is becoming more acute with anticipated loss of Dr. Kevin Carrigan at the end of 2013.
- 6. Annual Board Self-Evaluation: Form that was utilized for the past several years was distributed along with some other sample board self-evaluation forms. Committee will study these and make recommendations before 10/31. Will devote 30 minutes of next E.C. meeting to this topic to identify a self-evaluation tool to be used this year.
- 7. Annual CEO Evaluation: Consensus of the committee was that evaluation of the CEO should involve both outcomes derived from the organizational dashboard and from feedback obtained from board, direct reports and selected county officials. Committee to review the current feedback instrument and make recommendations prior to 10/31.
