1. Call Meeting to Order

The meeting of the Mount View Care Center Committee and the NCHC Nursing Home Operations Committee were called to order at 6:32 p.m. by their respective Chairs.

Discussion:

Michael Peer continued the prior discussion on the new policy options for MVCC:

- 1. Close and sell the property
- 2. Renovate the facility and continue operating
- 3. Cease County operations and sell to another provider

Closing the nursing home may take up to two years to accomplish due to legal requirements to place residents and the complexity of care required for ventilator and legacies residents. Each resident must have a transition plan. As the population reduces, your reimbursement stays the same, but your overhead is spread over a smaller population.

Maintaining staff becomes an issue and we may end up paying over the market, hiring temporary employees from firms specializing in such a service and creating "stay bonuses". Severance costs will likely be incurred.

Protective placements will cost between 1.3 and 1.8 million annually.

Renovating the facility needs to be coordinated with other facility plans.

Bonds can be partially repaid with an increased Medicaid rate.

Renovations will require planning to protect the residents and residents will have to move within the facility.

Renovations could cost \$16,000,000.

Selling the MVCC facility to another provider might be difficult to find. NCHC support operations may continue to support the new provider, but probably not to the extent they do now.

Broker fees and legal costs will be incurred.

Human Resource issues will need to be faced. Some NCHC employees may be employed by the new provider, but probably not all.

Both Kurt Gibbs and Bill Miller suggested that the goal of the group ought to be how can we serve people in need of skilled nursing care in a way that maximizes outside party reimbursement and reduces the tax levy contribution.
