Pine Crest Nursing Home

North Central Health Care is a multi-county organization representing Langlade, Lincoln and Marathon Counties. As part of the Joint County Agreement that creates our multi-county agency, each county can individually work with NCHC to have us manage other county operations that may or may not be delivered across all three counties. Over the years this has meant many different things such as managing Mount View Care Center (MVCC) and the Aquatic Therapy Pool on behalf Mar-

athon County or starting a Sober Living program on behalf of Langlade County. We are always open to these opportunities if they fit within our mission and vision.

Recently, Lincoln County has asked NCHC to temporarily manage Pine Crest, their skilled nursing facility located in Merrill. Pine Crest is a 180 licensed bed skilled nursing facility that is very similar in structure and size to MVCC. Pine Crest has had a long-term Administrator who has done a number of great things for Lincoln County and has recently made the decision to retire at the end of May. We have agreed to manage Pine Crest in the interim until at least the end of August. In agreeing to do so we have agreed to a couple key things:

- 1) Kim Gochanour, our Nursing Home Operations Executive, will serve as Pine Crest's full-time Administrator and will spend the majority of her time in Lincoln County. She will be available to NCHC staff and will participate in a number of our activities over the summer but until further notice, Kristin Woller, our Assistant Administrator, will serve as MVCC's point of contact for day to day operations for MVCC. Kim and Kristin will continue to have an ongoing daily interaction and will coordinate activities over the summer. The plan is that Kristin is now leading the team at MVCC through the end of August.
- 2) We will be offering support, education and consultative services to Lincoln County representatives from a number of NCHC Management Team members but mostly the CFO, HR Director and Director of Nursing. We will not be sending any MVCC direct care staff to Lincoln County.
- 3) We will be providing Human Resources recruitment services to support the recruitment of hiring a fulltime Nursing Home Administrator for Pine Crest by August 1, 2019.
- 4) We will be helping to update Pine Crest's budget format and financial reporting for 2019 as well as providing the Pine Crest Board of Trustees a proposed 2020 budget by early July.
- 5) I want to also be clear from the start, there will also be discussions throughout the summer on whether

or not it makes sense for NCHC to enter into a long-term arrangement for ongoing management of Pine Crest past August of this year. I am not sure where that decision will land but it will be discussed actively. If working together long-term does not make sense for both entities then we will have proudly helped a partner county to get over a hurdle. If it does make sense, then there will be a lot of activity later this year to get into the details of making that change happen.

This opportunity is a great one for NCHC to be a regional skilled nursing provider and to work together across county lines to lead and advocate for the long-term viability of county nursing homes




$\star\star\star$ SHEILA PYAN **Patient Accounts, MVCC**

CHANGES TO CRISIS CENTER ENTRANCE AT THE WHITE FLAG **MVCC Visitors Will No Longer Be Allowed Entry Through Crisis Center Doors**

As you know, the North Central Health Care Wausau Campus shares space with a variety of health care programs in addition to Mount View Care Center skilled nursing. As we seek to continually improve our safety and security on the Wausau Campus, a letter is being sent to inform all Legacies by the Lake residents and families of some changes that have taken affect regarding visitor entrances on the Wausau Campus for Legacies by the Lake programs.

Our Crisis Center and Emergency entrance and parking areas can become quite busy at times, and to ensure that our emergency services are operating at optimum levels, non-emergency parking and visitors through the Crisis Center, all non-emergency visitors will need to use a different entrance.

All visitors to Legacies by the Lake Dementia Care programs (Gardenside Crossing, Lakeview Heights and Evergreen Place) will no longer be able to access the neighborhoods using the Crisis Center parking area (white flag, door #55).

To visit these neighborhoods, visitors may park in the main MVCC parking lot (purple flag) and use the main entrance doors or you may park in the large rear parking lot area near Gardenside and enter in a side door near the Cafeteria (doors marked #47 or #48).

Signs are being installed to assist with these changes at the parking lot areas in the rear of the building.

WELLNESS CORNER

Muscle Sprain Treatment and Prevention

Gardening can be mentally refreshing; however, it can also wreak havoc on the muscles of the neck, arms, back and legs. Having properly working equipment and stools to sit on can lessen the strains on your muscles and back. Proper lifting, frequently changing positions and stretching can help to ward off some injuries as well. Symptoms of a muscle strain include pain and or tightness in a muscle group that has Sherry Gatewood been overworked. There could also be swelling and bruising. Most muscle strains heal on their own, but it may take a few days to a couple weeks.



If you do get a muscle strain, remember R-I-C-E: Rest- Ice-Compression - Elevation. Rest the affect part. Apply ice packs to the area over clothing or a towel for 15 minutes every 1-2 hours. Elevate the affected part. If needed, apply an elastic bandage to help relieve pain and swelling".

Over the counter analgesics such as ibuprofen (Aleve) and Acetaminophen (Tylenol) may also help. Avoid strenuous activity that may reinjure. Please call the Employee Health and Wellness Center and make an appointment if your symptoms are not improving as expected.

IMPORTANT: NOTIFICATION OF VOLUNTARY BENEFITS CARRIER CHANGE

After a thorough review process of voluntary benefit providers, North Central Health Care has selected Standard Insurance Company (The Standard) as our new carrier for the Voluntary Short Term Disability (STD), Accident and Critical Illness Insurances. This change will take effect on July 1, 2019.

IMPORTANT: All benefit eligible employees will automatically be enrolled in the new short-term disability plan and premiums for this plan will be deducted from pay checks starting in July 2019.

If you wish not to be enrolled in the new plan you are required to log into The Standard Insurance enrollment portal during the open enrollment period listed above to waive the coverage.

There will be an open enrollment period for the voluntary benefits beginning June 3, 2019 continuing through June 14, 2019. Please plan on attending a meeting to learn about the new provider and the voluntary benefits being offered.

All benefit eligible employees will be receiving a mailing at their home address with additional information regarding the new voluntary short-term disability plan.




