The End of Daylight Saving

Daylight savings has been around for hundreds of years. A prominent supporter of daylight saving in the late 1700's was Benjamin Franklin. He calculated that the city of Paris could save millions of pounds of candle wax by following daylight saving. This assumed of course that people would go to bed earlier and get up earlier saving the need to burn candles for light.

The history of daylight savings has evolved a lot in US history. It was first adopted in a bill in 1918 called seasonal time shift which only lasted 7 months before the bill was repealed. President Franklin Roosevelt re-established the concept labeling it as "War Time" where it lasted from February 1942 - Sep-

tember 1945. In 1946, the Uniform Time Act was approved which regulated a yearly time shift the last Sunday in April and end the last Sunday in October. It was changed once again in 1973 during the oil embargo

to implement a year-round daylight saving. The thought was that it would save energy through this crisis, but it showed little impact to energy savings. This lasted from January of 1974 through April of 1975 before the US switched back to standard time. From 1987 through 2006, daylight saving has started the first weekend in April ending the last weekend in October.

Starting in 2007, daylight saving starts the second Sunday in March and ends

the first Sunday in November. We still follow this schedule today in most of the US. There are two states that

NEW COVID-19 VACCINATION MANDATE – PLEASE READ IMMEDIATELY!

Many of you may have heard the news regarding the emergency regulation released on November 4, 2021 by the Federal Government requiring Covid-19 Vaccinations for all health care workers at facilities that participate in the Medicare and Medicaid programs. We want to clarify what this means to NCHC and YOU as an employee.

This new regulation applies to approximately 76,000 providers and 17 million health care workers in the United States that work at places like hospitals, assisted living facilities, nursing homes, surgery centers, public health centers, mental health facilities, clinics, rehabilitation centers, home health agencies and many, many more, as well as North Central Health Care. The new regulation aims to provide consistency across the medical field in the United States while combatting the increased risk of unvaccinated staff contracting the Covid-19 virus and transmitting it to patients.

The new regulation specifically states that health care facilities must establish a policy ensuring that all eligible employees receive their first dose of a two-dose Covid-19 vaccine, or a one-dose Covid-19 vaccine by December 5, 2021. The second dose of a Covid-19 vaccine (if required), will need to be administered by January 4, 2022. Additional boosters after staff have been fully vaccinated are not addressed in this regulation.

We know that this may cause some concern for those who have decided not to receive the Covid-19 vaccination and have completed the current declination form, however the new regulation will also provide exemptions based on medical conditions or religious beliefs, observances, or practices. These exemptions will align with federal law. While we encourage all employees to get the Covid-19 vaccine, these exemptions provide you with the choice to make the decision that is best for your personal health and one that will align with your religious practices in compliance with Federal law. The exemption form must be completed and on file with employee health by December 5, 2021.

As you know, NCHC has a policy in place already that requires staff to participate in our vaccination program. 61% of current staff across our organizations have already received the Covid-19 vaccine, while the remaining staff have a declination form on file with Employee Health.

So what will change with the new regulation?

The biggest change is that this regulation applies to all health care facilities, not just those that provide nursing home services. Because this new regulation is very specific to Covid-19 vaccinations, the Incident Command Team is in the process of adjusting the current NCHC Vaccination Policy to separate out the requirements for Covid-19 vaccinations, and other required vaccinations like the influenza vaccine or TB testing, and create a new Covid-19 Vaccination Policy that aligns with these new regulations.

For 61% of our employees no further action is necessary as your Covid-19 vaccination requirements are met. For the remaining employees and contracted staff working in our facilities, you will have the option receive the first dose of the required vaccination by Dec. 5, 2021 or complete the new exemption form which will be made available to you in coming weeks with the new Covid-19 Vaccination Policy.

This new regulation applies to ALL NCHC staff and contracted staff working in any NCHC program, not only our direct care programs, but all who work in any NCHC facility or program. It also applies only to Covid-19 vaccinations, and not to testing requirements. The current CMS testing requirements for nursing homes will remain in place that align with County positivity rates and outbreak situations.

The next scheduled Covid-19 vaccination clinics are shown to the right. Please watch for more dates and times to come in your work email and communication boards. There will be more information coming to you in the next few weeks. We encourage you to use the information included here to help other employees understand these new regulations and dispel any misinformation that is shared.

If you have questions, please reach out to your manager, director or any member of the Executive Management Team for clarification. Continue to wear a mask while at work, practice good hand hygiene, get vaccinated, stay home when you are ill and report symptoms to Employee Health and your manager. Please be safe and be well.

PPE GUIDELINES

Visitors: Cloth face covering or surgical masks required by all. Visitors to Nurs-ing Homes & Adult/Youth Inpatient Hospitals will be screened using the COVID Screener (Version 3). All other visitors will only require temperature check.

MARATHON: 11.98%

Employees: Face coverings <u>required</u> while entering the building. Self-screening required using temperature kiosks procedures. Surgical masks at a minimum required while within all NCHC buildings. Staff may remove masks while working alone in private offices.

Employees Working in Direct Patient/Resident Care:

Enhanced or Covid-19 Confirmed/Suspected Precautions must have it clearly posted on the entrance to the unit.

- o Standard Precautions Surgical Mask and Gloves required. Eye Protection (face shield, goggles or safety glasses) required during applicable isolation precautions.
- o Enhanced Precautions Surgical Mask, Eye Protection (Face shield, goggles or safety glasses), Gloves and Gown during patient encounters required
- o Covid-19 Confirmed/Suspected Precautions N95 Mask, Eye Protection (Face shield, goggles or safety glasses), Gloves and Gown during patient encounters required.

GENERAL OPERATIONAL GUIDELINES

Program admissions, closures, and operations will be determined by Incident Command daily. Updates provided to staff at least weekly.

Direct Care/Visitors

- Essential visitors and contractors only.
- In-person treatment allowed in all programs. Masks and social distancing required. All areas require departmental cleaning procedures for pre/post in-person visits. Virtual treatment optional.
- In-Person Visitation allowed at Nursing Homes, Inpatient Hospitals, CBRF and Residential Homes (unless noted to right).
 - Program-established visiting hours.
 - Visitation limited to designated visiting areas or resident rooms only. No other travel throughout facilities. 2 visitors maximum per resident/ patient at any time. Length of visit is determined by program.
- Indoor, window, compassionate care and outdoor visits allowed.
- Outdoor visits are weather-permitting and determined by program.
- Screening, masks and social distancing required.
- Volunteer programming allowed. Limited to 5 max at a time in building. Covid-19 vaccination required.

Meetings or Groups - Please refer to Alert Level Response

- NCHC in-person meetings allowed. Masks, 6-foot social distancing or physical barriers between individuals required.
- Treatment groups SUSPENDED at this time due to current community positivity rates. Only DBT & AODA Groups allowed.
- Non-NCHC groups or meetings are not permitted (i.e., AA, NA) in care areas (nursing homes, outpatient clinics). Wausau Campus Theater is allowed to be scheduled for outside group use. Contact Administration Office 715.848.4405.
- Group sizes for meetings limited based on each County's Positivity Rate. Masks & social distancing required. Meetings require Incident Command approval if in RED or higher # of people than desig. limit.

HR / Remote Work

- On-site interviews and Orientation are allowed with an option for virtual participation provided.
- Remote Work limited to those requiring exceptions. Please work with Manager and Human Resources if exceptions are required.


