
#### **Excavators, Backhoes and Cement Trucks**

I am extending "kudos" to the staff at North Central Health Care for partnering with Marathon County Health Department in the Mass Flu Clinic Functional Exercise held today. We met and exceed our objective; to vaccine 100 people within 90 minutes – our total was 104 NCHC and 23 MCHD employees. In addition, nursing staff from North Central Health Care and the Health Department experienced working together under an Incident Command System structure.

The partnership enabled us as a health department to practice carrying out a mass clinic that involved more than 100 people. This is critical practice, given the majority of our staff have been hired since we've conducted mass clinics in response to H1N1 in 2009-2010.

## PLANNING ON TRAVELING? **Tips from Our Purchasing Experts**

Thanks to Kelly Henke-Kaiser for this great tip on travel. As Kelly makes reservations, books flights and gets things aligned for travel for our employees, she wants you to be aware of these new require-ments for travel. Thinking of vacationing? Think ahead! Thank you Kelly!

Beginning October 1, 2020, you will need a REAL ID or driver's license. In an effort to thwart terrorism in travel a law was passed in 2005 to take steps to verify travelers' identity. What does that mean? If you might fly within the U.S., visit a military base or other federal building, the Department of Homeland Security will require identification that is REAL ID compliant (or show another acceptable form of identification, such as a passport). If you have a new driver's license and it does not have a star in the upper right corner, it is not REAL compliant. I recently obtained mine and the DMV is very particular as to the documents you present. You need a CERTIFIED copy of your birth certificate, marriage license(s) and divorce document(s). If you need to obtain these there is a cost from \$10-\$25 per copy. Go to the State of Wisconsin DMV

Organizational Development (OD) is pleased to announce that effective October 2019, we will implement a new Learning Management System (LMS), replacing HealthStream with UltiPro Learning for all staff.

The capabilities and enhancements of UltiPro Learning exceed those we have with HealthStream, and integrates with the new Human Resources and payroll system being implemented at the same time.



Over the next month, we will be working to download and print transcripts from HealthStream of completed modules and assignments of all staff to retain on file. As of September 20, 2019, Health-Stream modules, checklists and rosters must be completed. At that time, the HealthStream icon and link to the site will be removed from all NCHC staff computers. The UltiPro Learning icon will be added when the program goes live.

Face-to-face and online training of the new Learn-

ing Management System will be provided.

#### WAUSAU CAMPUS PARKING LOT NOTICES Effective 9/20/19

We know that as we move full steam into our renovation project on the Wausau Campus, it is necessary for us to continually assess our day to day operations for efficiency and also ensure that those we serve, our employees and visitors have a positive experience. We have received varying feedback regarding parking in the Wausau Campus over the last few weeks. Because of your feedback, we are making a few parking changes to try to alleviate full lots and make sure everyone gets to where they need to be in a timely manner. Please share with employees on your team.

#### NCHC Employee Parking Changes Effective 9/20/19

Physicians and Management staff only may park in the yellow flag parking lot in the farthest row from the main entrance. Many of these staff have varying hours, and frequently leave the Campus and this will free up spaces in the rear parking lot area.

All other employees will continue to park in the rear parking area nearest to Lake View Professional Plaza, or in the rear rows of MVCC purple flag lot.

Please avoid parking in the Health Department lot and walking to the front or side of the building if you do not have badge access by the Health Dept. This takes up spaces for the many traveling nurses in the Health Department who load and unload medical equipment frequently throughout the day.

Please do not bring trailers, boats and any pull-behind equipment with you to work.

We will continue to assess parking as we enter the change of seasons, knowing that it will be challenging as snow begins to fall. Stay tuned! Check your email and Communication Boards for detailed Maps.

#### Tobacco, Smoking and E-Cigarette Use Reminder

Additionally, we would like to remind staff that the NCHC Tobacco Use Policy prohibits smoking, tobacco and electronic cigarettes at all NCHC facilities, including parking lots, walking trails and natural spaces. Staff are allowed to smoke within their vehicles, and are required to extinguish those materials within their vehicle also, and not on the ground in our parking areas. 


### **COMMUNITY FEST 2019**

#### What You Need to Know **About the Flu Shot**

If you have not chosen to get your flu shot this year because you are concerned that it will make you sick, here is some information from the Centers for Disease Control and Prevention. There is proof that it does not make you sick with the flu.

According to the Centers for Disease Control and Prevention (CDC) the Flu Vaccine injection does not make you get the Flu. The injection that is given contains a weaker killed virus of the Influenza virus in order for you to make antibodies. Antibodies are chemicals in the blood that protects you from infections. They are developed when you are exposed to something that the body sees as foreign. It makes these antibodies that develop a memory of the invader the next time it is seen. Then the Antibodies attack it so that you don't get as sick or you may not get sick at all when exposed.

#### Why do some people not feel well after getting the seasonal flu vaccine?

Some people report having mild reactions to flu vaccination. The most common side effects from flu shots are soreness, redness, tenderness or swelling where the shot was given. Low-grade fever, headache and muscle aches also may occur. If these reactions occur, they usually begin soon after the shot and last 1-2 days. In randomized, blinded studies, where some people get inactivated flu shots and others get salt-water shots, the only differences in symptoms was increased soreness in the arm and

redness at the injection site among people who got the flu shot. There were no differences in terms of body aches, fever, cough, runny nose or sore

Side effects from the nasal spray flu vaccine (which is the live virus of influenza) may include: runny nose, wheezing, headache, vomiting, muscle aches, fever, sore throat and cough. If these problems occur, they usually begin soon after vaccination and are mild and short-lived. The most common reactions people have to flu vaccines are considerably less severe than the symptoms caused by actual flu illness.

#### What about people who get a seasonal flu vaccine and still get sick with flu symptoms?

There are several reasons why someone might get flu symptoms even after they have been vaccinated against flu.

One reason is that some people can become ill from other respiratory viruses besides flu such as rhinoviruses, which are associated with the common cold, cause symptoms similar to flu and also spread and cause illness during the flu season. The flu vaccine only protects against influenza, not other illnesses.

Another explanation is that it is possible to be exposed to influenza viruses, which cause the flu shortly before getting vaccinated or during the two-week period after vaccination that it takes the body to develop immune protection. This exposure may result in a person becoming ill with flu before protection from the vaccine takes effect. This is another good reason to get the vaccine before the flu season starts.

A third reason why some people may experience flu like symptoms despite getting vaccinated is that they may have been exposed to a flu virus

that is very different from the viruses the vaccine is designed to protect against. The ability of a flu vaccine to protect a person depends on the similarity or "match" between the viruses selected to make the vaccine and those spreading and causing illness. There are many different flu viruses that spread and cause illness among people.

The final explanation for experiencing flu symptoms after vaccination is that the flu vaccine can vary in how well it works and some people who get vaccinated may still get sick.

But in the long run, those who are given the flu vaccine do not get as sick or remain sick as long as those who do not get the vaccine.

# 2019 INFLUENZA VACCINATIONS **REQUIREMENTS BY ALL NCHC STAFF**

#### **Did YOU Get Your Flu Shot Yet?**

- 1. All NCHC employees are required to complete the Annual Employee Health Questionnaire and receive an Influenza Vaccination by November 1st, 2019
- 2. The forms will be sent to you via email are fillable. Please complete and print off both before receiving influenza vaccine. The Vaccine Information Sheet (VIS) is for your information only and does not need to be printed.
- 3. Employees that DO NOT complete, by November 1st 2019 are to be removed from the schedule until both items have been completed and this can also affect your Performance Evaluation Merit Increase.
- 4. Employees that are unable to receive the vaccination due to exemptions, please contact Renee Erickson during her flu shot office hours. (Please see below)
- 5. If your program is listed below, please see the designated person for your flu shot.
