<b>What is the overall deductible?</b>	\$2,500/person or \$7,500/family for In-Network Providers. \$5,000/person or \$15,000/family for Out-of-Network Providers.	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay.
